Updates:

Attendance

Edwin Mendez, Director of Attendance, shared recommendations and guidance regarding "What Parents can to do improve attendance and ensure children are ready to learn", with committee members. These guidelines will be shared with families and community members. District HIB Coordinator Rashon Dwight gave an update on the final 2021-2022 district data.

Updates Continued

Truancy Task Force (TTF)

Darrell Major, Manager Specialist of Truancy Task Force explained the mission and functions of the Truancy Task Force. He informed the committee of the following 2022-2023 initiatives:

- Regional Truancy Task Force collaboration with surrounding districts
- Collaboration with the Newark Police Department, two police officers accompany our Truancy Team daily.
- Truancy Task Force Safe Passages Initiative
- Truancy Task Force Hotline, distributed to local businesses, residents, and community.
- Truancy Task Force Social Worker for follow up, interventions, and family support

Harassment, Intimidation, and Bullying (HIB)

Rashon Dwight, District HIB Coordinator reviewed the purpose and process of HIB reporting. He informed the committee of the following updates:

- Attended training to understand the major changes in NJ HIB Law
- Provided HIB overview training for School Support Staff, including updates to NJ HIB laws
- Collaborating with the General Counsel Department to include NJ HIB Law updates in district HIB policy
- Distributed new NJDOE-created HIB 338 Forms to school Anti-Bullying Specialists

Parent Engagement

Michelina Thornton, Director of Parent Engagement and Federal Grants presented the following updates to the committee:

- Office of Federal Programs & Grants partnered with Amerigroup to host a Back to School Resource fair. It was held on September 8th at Mt. Vernon School. All schools in the South and West wards were invited. There were many community organizations participating with over 1,500 participants who received backpacks, school supplies, books, groceries and resources.
- Parent Engagement Team hosted 2 professional development sessions for parent liaisons.
 - 1. August 31st *Topics*: Title I, Grants and Parent Resource rooms
 - 2. September 13th Topics: Parent Portal, Parent Resources, Action Plans
- Parent University Fall sessions are all self-paced learning modules on the district website. Parents can find videos on 9 different topics:
 - 1. Orientation to NBOE; Technology; Curriculum & Instruction; Health & Wellness; Social Emotional Learning & Mental Wellness; Parenting; High School/Post-Secondary; General Studies & Skill Development.
- Parent Resource rooms Each school was asked to identify a space for parents and families. We will continue working with parent liaisons to ensure all rooms have resources for families.

• Community Resource Directory - This online platform is now on the district website that includes information on community organizations for housing, food, and other needs to help bring resources to families.

Office of Student Life:

Mary Leigh Harvey, Director of Student Life provided the following OSL updates:

- The *Mindright* pilot is begin with a launch meeting on September 20th with select high school staff.
- Through Youth Development Clinic, Effective Schools Solutions, and Supreme Consultants, clinicians continue to be interviewed and recommended as contingent workers to support student mental health and wellness. Clinicians will provide school based counseling services to students. These organizations will also as support to teachers and parents by providing workshops. Additionally, clinicians will coach schools on the effectiveness of their referral process and school-wide support team structures to address the trends that impede learning.
- Provided McKinney Vento initial overview training to school-based support staff, i.e. school counselors and social worker 2s.
- Collaborating with local agencies to secure presenters for the 22-23 SY McKinney-Vento Resource Hour.
- Mentor Newark provided mentor coordinator and mentee training sessions with Bard Early College to assist with their peer-to-peer mentoring program.
- Grant applications were submitted the New Jersey Child Assault Prevention and NJ CAP - Bully Prevention programs. The participating schools are Abington Avenue School, McKinley Elementary School, Rafael Hernandez School, Harriet Tubman School.
- Staff from the Office of Student participated in the School Based Community Resource Fair at Mount Vernon on September 8, 2022.
- As part of National Hispanic Heritage month and to promote and advocate for Antibullying, staff from OSL participated and assisted participating schools, Abington, Chancellor, Harriet Tubman, Oliver and Speedway in the Anti-Bullying March held on September 14, 2022.
