Meeting Summary

Chair Murray-Thomas called the m	eeting to order at	5:04.	

Dr. Reilly began with a review of the agenda.

At 5:05, Assistant Superintendent Dr. Jose Fuentes began the meeting with an introduction of the North Ward School Leadership team: Special Assistants Crystal Joye, Andres Barquin, and Alan Usherenko. Dr. Fuentes share the following data points regarding the North Ward schools:

-Academics

- -Behavioral
- -Enrollment

Staffing

-Attendance

-Highlights of the North Ward schools were presented. Some mentioned were as follows:

- Franklin school has expanded to include 7th grade and continues to increase community partnerships. Franklin School has entered year 3 of their SEL grant.
- 0 Dr. William H. Horton school has received a Verizon IPad Grant and has a Verizon Innovative lab. Algebra I and AP Spanish courses are also available to students.
- 0 Elliott St. school has received the Keys of Inspiration Grant that provides 30 Roland pianos for students in the second grade for three years.

At 5:34, the meeting opened for questions and answers.

- Board Member Norton inquired about SEL data. The district's data revealed students expressing the need to reunite. Some interventions that have been put in place are character development and self regulation lessons for the entire class. Self regulation corners and TLC rooms give opportunities for students to express themselves. Training for teachers on what to look for and how to refer students has also been implemented.
- How are schools partnering with each other to support one another?
 - Deputy shared SLT meetings provide opportunities for principals to share and learn from one another. Walkthroughs, triads and buddy systems for principals also support schools across SLTs.

At 5:45, Deputy Johnson shared the guidance for remote instruction requirements.

- The emergency remote instruction plan must be submitted annually and will be in effect during a district closure lasting more than three consecutive days due to a declared state of emergency.
- The Remote Plan is due to the county office for review and approval by October 29th. It will also be posted on the district's website.
- Board Member Norton recommends this to be moved to full board for approval.
