Meeting Summary			

The Finance Committee convened for its monthly meeting on Thursday, November 17, 2022, at 5:32 pm. The meeting began with Budget Director Elvis Matos presenting the Quarterly Forecast.

Mr. Matos gave details on FY 22-23, Quarter 1 Forecast. This forecast is providing a status on the District's current financial condition. This forecast does not include any of the Grant Funding such as ESSER I, II, or III. The FY 21-22 unaudited actual expenses which are subject to change once the audit is completed in December 2022. For FY 21-22 net change is \$46 million. The original budget for the current fiscal year (22-23), the operating budget is \$1,226,969,311. The District anticipates savings of approximately \$9.0M through the first quarter. Potential Risks are currently unknown. The next quarterly forecast is in February, which will include more in-depth forecasting.

Ms. Valerie Wilson, SBA proceeded to present this month's agenda items as well as an NJQSAC update, the ARP Spending Analysis, ESSER II Spending Analysis, and Year 3 Quarter 1 Strategic Plan Highlights and Deliverables. Several Agenda items were discussed, such as:

The Award of Design Consultant Services for Emergent and/or Capital Projects, which helps utilize ESSER funds on Architectural designs was discussed. Board member A'Dorian Murray-Thomas questioned if in the foreseeable future are any mechanisms in place to adjust normal income/revenue post-COVID-19 surplus funding. Ms. Wilson did respond we already have been planning now to make a continuous effort to spend our budget on non-occurring items. Such as the twelve hundred new smartboards that have been installed, technology updates, and contactless water fountains. Any available funds we have are being utilized now. The Submission of the Comprehensive Maintenance Plan, which ensures schools are being maintained. The Continued Used of Temporary Classrooms, which mentions all the schools that use additional educational spaces. The Aviation Institute of Maintenance

Purchasing Reference, which is a new program that will be utilized in Career and Technological Education (CTE), helps students in high school to take aviation courses and earn certifications. Board Member Hasani Council requested comparisons of vendors for this program. The Authorization of District Travel is being used proactively and efficiently. Those who need reimbursement must meet ALL designed deadlines and submit a request to the County if needed.

SBA Wilson gave an update on NJQSAC. The Board reviewed the District performance indicators of the five areas, and the declaration page and passed a resolution. All three items were submitted to the NJDOE Homeroom as required. This action moves the District to the next step in the process in preparation for the on-site visit.

The District will continue working on water fountains that are not operable but have been tested. Meanwhile, the District has been installing contactless water fountains in several schools and will continue this process using district staff and a contractor. The Office of Education Technology implemented the Edulastic platform to provide educators with a more robust platform for gathering student data to support informed decision-making on groupings, lesson planning, and lesson pacing.

The Office of Pupil Transportation has been working diligently to start a new program with NJ TRANSIT that allows High School students to receive a monthly bus pass instead of bus tickets. With this monthly bus pass students will be able to use it outside of school for after-school or weekend jobs, athletic activities, etc. This program will effectively start on January 3, 2023, for all high schools.

The meeting concluded with presentations on ESSER II Spending Analysis and ARP Spending Analysis update.
