Personnel Matters

Ms. Liss presented tenure charges of inefficiency against employees S.M. and J. F. and tenure charges of unbecoming conduct and other just cause against employee L. H.

There was a motion by Ms. Norton, seconded by Ms. Santana, as follows:

- Determining that the school district has followed the evaluation process as to employee S. M. during the 2020-21 and 2021-22 school years, and therefore that the tenure charge of inefficiency against S. M. shall be submitted to the Commissioner of Education and S. M. shall be and hereby is suspended, effective August 30, 2022, without pay for 120 days and with pay thereafter during the pendency of the tenure charge.
- 2. Determining that the school district has followed the evaluation process as to employee J. F. during the 2020-21 and 2021-22 school years, and therefore that the tenure charge of inefficiency against J. F. shall be submitted to the Commissioner of Education and J. F. shall be and hereby is suspended, effective August 30, 2022, without pay for 120 days and with pay thereafter during the pendency of the tenure charge.
- Determining that probable cause exists to credit the evidence against employee L. H. in support
 of the tenure charges and that same are sufficient to warrant dismissal, and therefore that the
 tenure charges of unbecoming conduct and other just cause against L. H. shall be submitted to

the Commissioner of Education and L. H. shall be and hereby is suspended, effective August 30, 2022, without pay for 120 days and with pay thereafter during the pendency of the tenure charges.
