Meeting Summary		

The Finance Committee convened for its monthly meeting on Thursday, November 18, 2021, at 5:35 pm. All Committee Members listed above were in attendance. The meeting began with School Business Administrator, Valerie Wilson discussed the agenda items as reflected in these minutes.

Elvis Matos, Director of Budget, spoke about the FY 21-22 Quarterly Forecast. He gave details on revenues, expenditures, and expenses. According to the Transition Plan, there will be three quarterly forecast: November 2021, February 2022, and June 2022. Assistant School Business Administrator, Imani Moody discussed the Impact of Covid-19 to Student Transportation Increase in Cost and Decrease in Vendor Availability for Field Trips. It can take up to two weeks for Office of Pupil Transportation to secure transportation.

Valerie Wilson, School Business Administrator, discussed several topics, such as the Federally Funded ESSA and ESEA Programs, designed to improve and make progress towards student achievement. The Extended Day Enrichment Services Award includes a summer program for students within the Newark School District. At East Side High School, elevators are dilapidated and need repair and modernization. Other discussion topics were the Renewal of Mentoring Professional Development Services which is provided to staff and to support positive youth development. Document Cameras are used in classrooms to enable student and teacher learning engagement.

To conclude the meeting, SBA Wilson gave information on ARP/ESSER II Spending, Enrollment Memorandum of Understanding, the Budget calendar, the Budget Committee members and meetings, and the Election Calendar. SBA Wilson also spoke about the lease update for 155 Jefferson Street and the St. Chasimir's locations.
